

RESOLUTION NO. 2006-3329

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR GENERAL OPERATIONS AND VOTED GENERAL OBLIGATION DEBT SERVICE FOR THE CITY OF MIAMI SPRINGS FOR THE FISCAL YEAR 2006-2007; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Miami Springs, Florida has held the first of two public hearings on September 11, 2006 as required by Florida Statutes 200.065 to discuss the proposed operating and debt service ad valorem levies; and,

WHEREAS, the City Council of the City of Miami Springs, Florida has held the first of two public hearings on September 11, 2006 as required by Florida Statutes 200.065 to discuss the proposed operating budgets of the City of Miami Springs for the Fiscal Year beginning October 1, 2006 and ending September 30, 2007; and,

WHEREAS, the City Council of the City of Miami Springs, Florida passed two resolutions following the public hearing tentatively adopting the proposed operating and debt service ad valorem tax rates, concurrent with the proposed operating budgets; and,

WHEREAS, the value of real property not exempt from taxation within the City of Miami Springs, Florida has been certified by the Miami-Dade County property appraiser and reflects a current year adjusted taxable value of \$1,009,401,561; and,

WHEREAS, the second public hearing was duly noticed, advertised and held on September 25, 2006.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA:

Section 1: That the Fiscal Year 2006-2007 OPERATING millage rate for the City of Miami Springs, Florida is **7.5000 mills**, representing a 6.5750% increase over the rolled back rate of 7.0373 **mills**.

Section 2: That the Fiscal Year 2006-2007 voted GENERAL OBLIGATION DEBT SERVICE millage rate for the City of Miami Springs, Florida is **.3953 mills**, the **ninth** year of the voted debt service levy.

Section 3: That this resolution shall take effect immediately upon its adoption.

PASSED AND ADOPTED by the City Council of the City of Miami Springs, Florida, this 25th day of September, 2006.
