NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA:

Section 1: That the amended Schedule of Charges attached to this Resolution is hereby approved and adopted.

Section 2: That the attached Schedule of Charges may, from time to time, be further amended upon the recommendation of the Administration and subsequent approval by the City Council.

Section 3: That provisions of this Resolution shall become effective upon passage.
