<b>Date/Day</b>	<b>Activity</b>
<b>Tuesday</b> <b>07/03/2012</b> <b>1359 hrs</b>	A worker at 4299 N. W. 36 Street, a construction site; left his iPad on top of a box in a room next to where he was working. Later when he went to retrieve the iPad it was no longer where he left it. The estimated loss is \$1,100.00.
