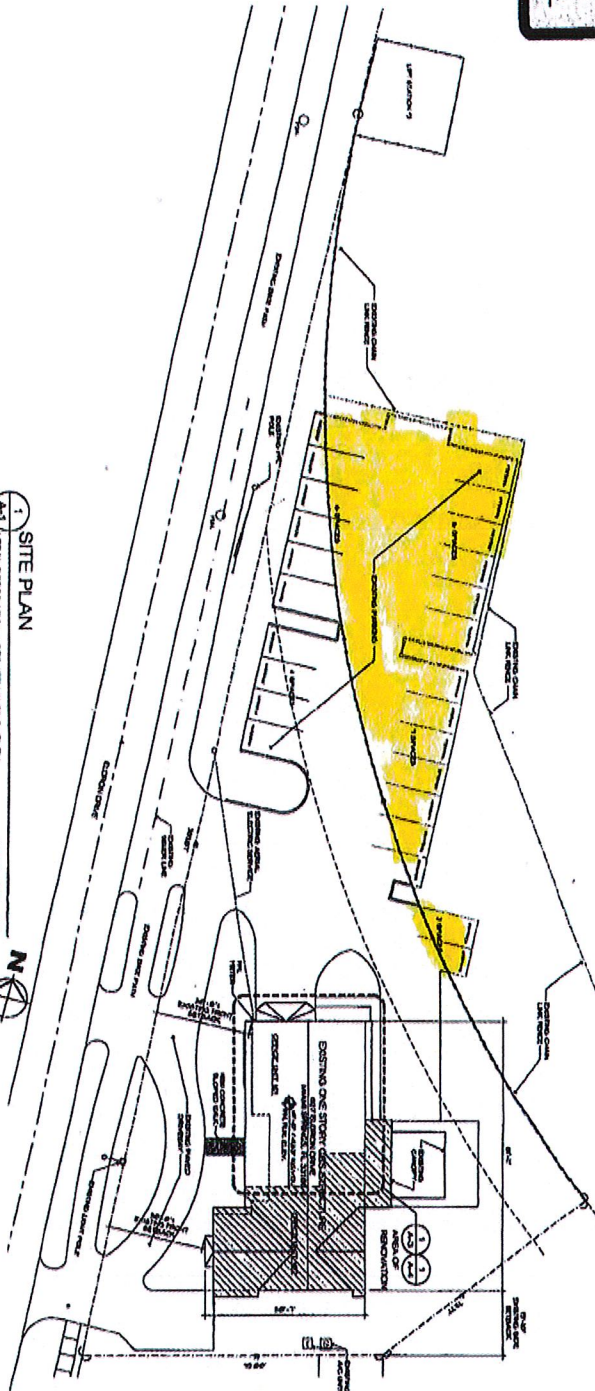

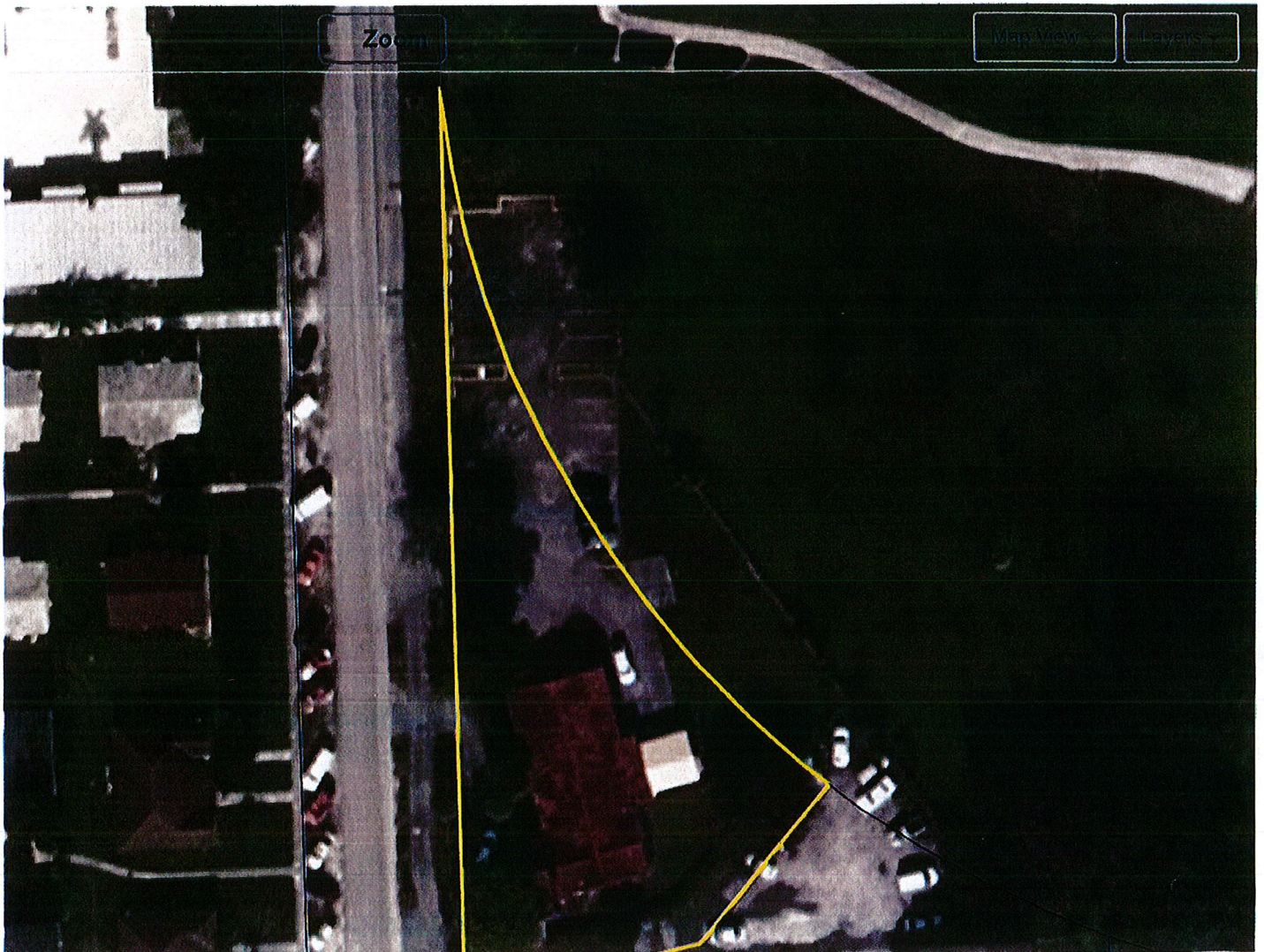
1 SITE PLAN
