Pension Plan" Of The City's Code Of Ordinances By Amending Section 35-51, "Definitions" Pertaining To "Average Monthly Earnings"; Amending Section 35-53 "Benefit Amounts And Eligibility" To Exclude Members In The Rank Of Lieutenant And Below Retiring Or Entering The Drop After December 14, 2021 From The Provisions Relating To Frozen Accrued Benefits; Providing For Conflicts; Providing For Severability; Providing For Codification; And Providing For An Effective Date

Councilman Vazquez moved to approve the Ordinance on first reading. Councilman Best seconded the motion, which carried 5-0 on roll call vote. The vote was as follows: Vice Mayor Bravo, Councilman Best, Councilman Fajet, Councilman Vazquez, and Mayor Mitchell voting Yes.

12. Other Business:

A) Update by Mayor Mitchell on Tallahassee Dade Days and Florida League of Mayors

Mayor Mitchell stated that she and several members of the City Council joined the City Manager in Tallahassee for the annual Dade Days event. She stated the event ran for two days from February 2-3 and were able to meet with the Cities state representatives, Representative Bryan Avila and Senator Manny Diaz, Jr. on City priorities. Councilman Fajet stated it was his first time attending and said that it was very valuable and a great experience overall to see our legislators at work. Vice Mayor Bravo also said that was her first time at Dade Days and said it gave her a different perspective on government and the City's representation in Tallahassee. City Manager Alonso expressed that the City's items are moving forward and have not been voted down, the City will know by mid-March on the proposed items for State approval. Mayor Mitchell continued to state that she also participated in the Florida League of Mayors events in Tallahassee as well the week following Dade Days. She updated the City Council on items discussed during the FLM events, such

as, short-term vacation rentals, and bed-tax issue.

B) Update by Mayor Mitchell on Miami-Dade County League of Cities Board meeting on February 10th at the Miami Springs Country Club

Mayor Mitchell stated that the last Miami-Dade County League of Cities Board Meeting was held at the Miami Springs Country Club on February 10th. Councilman Best stated that the Mayor's presentation on the "Bed Tax" issue was flawless and to the point. Councilman Vazquez stated he was happy to be there and participate at the event. Mayor stated that it was also the City Manager's birthday that night, it was nice to celebrate all together.
