

EXECUTIVE SUMMARY

INTRODUCTION

THA Consulting, Inc. (THA) has been retained by the City of Miami Springs (the City) to perform a parking study focusing on the downtown area. Based on our multiple project meetings, The Parking Study Request for information and the public engagement meeting held on September 14, 2023, we understand there are concerns regarding the new developments taking place downtown and their impact available public parking, downtown accessibility and on residential quality of life for Miami Springs residents adjacent to the downtown.



The City was founded in 1926 and is bordered by the Miami International Airport, the Village of Virginia Gardens, the City of Hialeah, and the Town of Medley. Miami Springs has just under 14,000 residents within the 2.9 square mile City limits and is overseen by a City Manager and five elected officials. The City is located approximately 8 miles from Downtown Miami and 10 miles from Miami Beach.

Parking Study Scope of Services


The four components of this effort include:

- 1. An examination of the existing on- and off-street public parking infrastructure in order to understand the <u>current</u> <u>parking adequacy</u> (surplus or shortage).
- 2. Determine the future parking demand based on lease up and pending development projects to quantify the <u>future</u> <u>parking adequacy</u> (surplus or shortage).
- 3. Review the existing <u>parking management and operations</u> and identify opportunities for increased efficiency and provide recommendations based on best practices.
- 4. <u>Engage the local stakeholders</u> in order to obtain feedback on the current perceptions of the parking system, challenges, and desired changes.




Study Area

The City of Miami Springs is located directly north of the Miami International Airport and approximately 5 miles northwest from downtown Miami. A map depicting the location of Miami Springs in relation to the Airport, Downtown Miami, Miami Beach, and Hollywood is shown below.

The City of Miami Springs is *bordered* by US 27, NW 36th Street, and NW 67th Avenue and our study area is focused on the downtown district which is generally bordered by Esplanade Drive, Canal Street, Pinecrest Drive, and South Drive. A map depicting the exact boundaries of the study focus area is included on the following page.


We looked at various walking distances and **the entire study area is within a 5 minute walk** to the Circle with the exception of the far western portion along Westward Drive between Morningside Drive and Esplanade Drive.

2023 PARKING CONDITIONS

The THA team physically surveyed all the on- and off-street public parking areas within the study area during multiple site visits occurring on Tuesday, February 28th through Thursday, March 2nd, 2023, and again from Wednesday, September 13th through Saturday, September 16th, 2023. Please note, the City requested a project delay for the performance of the occupancy counts to allow the development projects underway to be completed, leased, and occupied. Unfortunately, those new projects were not fully leased and occupied prior to our team returning to conduct the September occupancy counts. For that reason, we have projected the future parking needs of the various development projects and included them later in this report. The data listed in this section of the report represents the inventory and occupancy data collected by our team on the dates listed above.

During our site visits, we were able to both drive around the study area to make observances as a motorist as well as walk around to understand the pedestrian experience. Our time in Miami Springs allowed us to experience the general feel of the City as we dined and spent time observing how vehicles and pedestrians moved around the area.

The roundabout "Circle" area was consistently busy throughout the day and given its location at the heart of the City where most of the economic activity (and new development) is occurring, we believe understanding how this area functions is a critical part of this parking study. Traditionally a roundabout improves congestion and aids with the movement of vehicles. In Miami Springs, the <u>Circle consists of 9 entry lanes and 8 exit lanes point (a total of 17 lanes)</u> which are all entering and exiting the 240' wide roundabout. In addition, the City's Circle Park is located in the middle of this traffic roundabout with a single pedestrian crossing from between the two directions of travel along Curtiss Parkway. Pedestrian crossings are located adjacent to the Circle entry and exit points which require pedestrians to carefully navigate crossing those areas with vehicles passing around the circle. An aerial map is shown below to visually represent the vehicular and pedestrian paths of travel at the Circle.



Our team also observed multiple instances where motor traffic was backed up and blocking the flow of vehicles around the circle (photo right). Likewise, we observed vehicles exiting the circle to the south onto Curtiss Parkway and traveling down that road well over the posted speed limit of 30 miles per hour. We understand many motorists cut through the City of Miami Springs and use Curtiss Parkway to quickly navigate to the south towards (towards 36th avenue and the airport). We also observed vehicles traveling at excess speeds beyond the posted 25 miles per hour speed limit along Westward Drive but there were fewer vehicles on that stretch of the roadway in comparison to Curtiss Parkway.

During our site visits, which occurred over 6 days, we did not observe any police activities enforcing the posted speed limits on Curtiss Parkway or Westward Drive. Nor did we observe <u>any</u> parking enforcement activities during our visits. During our visits, we also noted the posted time limits are not currently enforced and many of the posted regulations (time limits) are inconsistent. For example, parking is restricted to 2 hours on one side of Westward Drive but there are not any time limits on the opposite side. We also noted parking violations such as double parking (photo right), and parking too close to an intersection, none of which received a citation.

Finally, there are areas where the on-street public parking spaces are used solely for the purpose of accommodating drop-off and pick-up for students. The area along Morningside Drive (photo right) is regularly closed off in the morning and afternoon hours. Likewise, similar activities are taking place on the northern section of Park Street, north of Nahkoda Drive, which causes a significant amount of vehicular congestion during those hours. There may be a need to relocate drop-off zones and restrict use of these public on-street spaces in the future as the parking demand increases.








Parking Supply

The total public parking supply within our study area consists of approximately 449 parking spaces. Of those, 324 spaces are located on-street while the other 125 parking spaces are located in one of the 5 off-street parking lots. Please note, a large majority of the on-street parking spaces are unstriped spaces meaning there is no paint on the roadway to depict where each individual vehicle should park, and therefore our team estimated the capacity based on industry standards. During the time of our site visits, the on-street parking spaces located along Curtiss Parkway between Canal Street and the Circle (adjacent to the Springs Town Center development) were under construction as were both sides of Canal Street between Curtiss Parkway and Hook Square.

The first impression of parking in Miami Springs is very congested in the area adjacent to the Circle but there is an increasing amount of available parking when traveling away from the center of downtown along Westward Drive. A map depicting the location of the public on- and off-street parking areas is included on the following page.




Figure 4: Map of the Existing On- and Off-Street Public Parking Areas

2023 Parking Demand and Occupancy

Parking Demand refers to the number of parked vehicles observed or recorded at a specific time and date. Parking Occupancy refers to the portion, represented as a percentage, of parking spaces that are occupied by vehicles at a specific time and date. THA conducted field observations and collected parking data on Thursday, September 14, 2023, from 8AM to 7PM and on Saturday September 16, 2023, from 9AM to 8PM. During our collection days, the weather was typical for this time of year and there was no precipitation or other conditions that would negatively impact the data collected.

The peak hour demand occurred between 11:30AM and 1:30PM on the weekday and between 12PM and 2PM on the weekend. <u>The overall busiest time observed was during the weekday between 11:30am and 1:30pm with 273 parked vehicles</u>. We purposely did not perform field observations or data collection efforts during a special event and during the typical Saturday, found the peak hour weekend demand to be less than the levels observed during the week.

As noted above, the busiest hour observed was at an occupancy rate of only 61%. The weekend peak hour occupancy was much lower at 36%. This does not mean that there were not areas of high demand, just that the parking occupancy within the entire study area reflects enough parking spaces to meet demand at this time. When looking at specific high-demand areas, the weekday occupancy counts were consistently high and above the 85% desired levels. Heat maps on the following pages illustrate the distribution of demand throughout the study area for the three weekday and weekend occupancy counts.

The on-street parking areas along Park Street and Morningside Drive were heavily congested due to school drop off lines and/or parents parking to walk their children to the door. The on-street parking areas adjacent to Starbucks were busy consistently throughout the morning hours and traffic congestion was high as many vehicles use this corridor to bypass other north-south routes.

The peak hour parking conditions increased significantly compared to other times of the day. The on-street parking spaces throughout the study area were all well utilized with the exception of Morningside Drive, the center portion of Canal Street between Nakodah Drive and Nakodah Drive, and the parking lot south of Westward between Park Street and Cross Street.

The parking conditions during the early evening hours shifted from high business use to more restaurant and other activities. As shown above, most of Westward Drive was busy and many vehicles were patrons or employees for one of the nearby restaurants. We believe other evening activities were occuring at the Women's Club which is why the adjacent parking lot was heavily utilized.

Weekend parking conditions during the morning hours were considerably lower in comparison to the weekday parking conditions, primarly due to the absence of office employees. Again, the area around Starbucks was consistently busy as were the areas adjacent to restaurants serving breakfast.

As during the weekday, parking activity increased during the lunch hours with the highest demand focused around the Circle and the eastern portion of Westward Drive.

While the weekend evening parking conditions increased adjacent to the Circle, most of the other parking areas experienced a decrease in parking utilization.

Effective Parking Supply

Effective supply is a common term used in the parking industry. The effective supply is a "cushion" used to account for parking spaces lost due to misparked vehicles, construction, the difficulty to locate parking (i.e., line of sight via major roadways), and the natural ebb and flow of vehicles. Simply stated, it considers that a parking supply operates at a peak efficiency when parking occupancy is no greater than 85 to 95 percent of the supply. When occupancy exceeds this level, patrons may experience delays and frustration while searching for the last few remaining spaces. This creates a perception that the supply is inadequate even when there are some spaces still available.

For this study, we have assigned a 15% cushion (85% effective supply factor) to all on-street parking spaces and a 10% cushion (90% effective supply factor) to all off-street parking spaces for an average 14% cushion. The result is 387 effective parking spaces which reflect a cushion of 62 spaces. Table 4 summarizes the effective supply factor assumptions and the effective parking supply.

2023 Parking Adequacy (Surplus/Shortage)

To calculate the parking adequacy, parking surplus or shortage for the study area, we compare the peak-hour parking demand against the effective parking supply as previously calculated. Table 5 summarizes the parking adequacy for each type of facility surveyed in this analysis.

Based on the above table, <u>there is a current 114-space parking surplus during the weekday, daytime hours and a</u> <u>224-space parking surplus during the weekend, daytime hours</u>. Therefore, we can assume that the City has enough parking capacity available to meet all the existing users. However, based on public input, those available parking spaces are not located in suitable areas.

Key Observations

According to THA's field observations on weekdays and weekends:

- 1. There is an overall parking surplus. However, the demand is not distributed throughout all the public parking in the study area, resulting in a perceived parking shortage for many users, especially in the area adjacent to the Circle.
- 2. The public parking system is not being actively managed and parking regulations are not being followed or enforced to promote turnover and availability of the most convenient spaces.
- 3. Public parking Lots are not well defined in a traditional sense as there are not any noticeable "gateway" indicators, lot signage or formal names informing the public as to their availability.



- 4. Minimal traffic calming efforts are taking place which reduces the walkability of the area.
- 5. Speed limits were not followed nor were violations enforced, which also reduces the walkability of the area.

ESTIMATED FUTURE PARKING CONDITIONS

Springs Town Center (A)

The Springs Town Center (rendering right) is expected to be fully operational by May 2024. The development consists of 51 residential units, just under 24,000 square feet of commercial use, and a 98-space parking garage. To project the future parking needs of this project, we estimated the parking needs for the residents (and guests) separately from the parking needs of the commercial customers and employees. We understand the upper levels of the garage built as part of the project will be reserved for residents only and the ground floor will be available to retail / restaurant customers and employees.



Based on the Springs Town Center (A) development program information provided, we have assumed the following: 11,260 sq.ft. of full-service restaurant use, 2,500 sq.ft. of café/yogurt/quick service food use, 3,815 sq.ft. of medical use, and 6,130 sq.ft. of service retail use. Based on the commercial tenant mix, we have estimated the residential and commercial parking adequacy as follows:

We estimate a need for an additional 76 parking spaces during the weekday peak hour and 96 spaces during the weekend peak hour to accommodate all the users of the Springs Town Center Development. We also estimate a need for approximately 33 spaces to accommodate overnight residents and guests (10p-6a).

Barry's Cleaner's Development (B)


The Barry's Cleaner's Development project includes 8,030 square feet of commercial use and 6 parking spaces. Based on the development program information provided, we have assumed the following: 1,780 sq.ft. of full-service restaurant use, 1,200 of café/yogurt/quick service food use, 2,550 sq.ft. of service retail, and 2,500 of general retail. Based on the commercial mix we have estimated the parking adequacy as follows:

Adventist Property Development -1 S. Royal Poinciana (C)

The Adventist Property Development project includes 5,940 square feet of new commercial use. Based on the development program information provided we have assumed the following: 3,508 sq.ft. of service retail and 2,432 sq.ft. of café/yogurt/quick service food use. This site does not include any off-street parking spaces and all of the customers and employees utilize public parking. <u>Based on the commercial mix approximately 19 additional parking spaces will be needed during the weekday peak hour and 20 additional parking spaces will be needed during the weekend peak hour. Details are included in the following table.</u>



Hook Square Development (D)

The Hook Square Development project includes 1,750 square feet of new commercial use and 51 existing surface parking spaces. Based on the development program information provided we have assumed the following: 1,450 sq.ft. of service retail and 1,300 sq.ft. of counter/quick service food use. The Hook Square property includes 51 off-street parking spaces and based on our field observations in September 2023 the current lot reached full capacity on several occasions.

Based on the commercial mix we have estimated the additional parking demand will be approximately 18 and 24 new parking spaces during the weekday and weekend peak hour, respectively. The detailed breakdown is included below.



Backfill Commercial

We have assumed all commercial uses that are moving from one location to another location within the study area will be replaced with a similar business that generates a similar parking demand.

Future Public Parking Supply


Based on the striping plan provided by City representatives, there are an additional 35 on-street parking spaces on Canal Street that have been opened since the time of our initial parking occupancy counts. The 10 parking spaces on the east side of Curtiss Parkway were opened during our parking occupancy counts and have already been included in the 2023 parking conditions section.

Future Parking Adequacy

After all of the proposed development occurs and is fully leased/occupied, the existing 114-space weekday peak hour surplus is expected to decrease to a 26-space parking shortage for that same time period. However, the existing 160-space weekday evening surplus is expected to decrease to a 35-space parking shortage.

Likewise, the 224-space weekend peak hour surplus will be reduced to a 44-space peak hour surplus and the weekend evening 276-space parking surplus is expected to decrease to a 6-space parking shortage. In other words, the overall parking patterns in Miami Springs downtown study area -are expected to shift from peak hours occurring during the mid-day hours to the evening hours. This is directly associated with the increase in the number of restaurants as well as the residential component.

All four of the development projects are located adjacent to each other in an area that is already experiencing the highest traffic congestion and parking utilization in the City (image below). Furthermore, the location of these projects abutting residential areas and the canal creates a natural boundary, further taxing the limited parking infrastructure. The table on the following page outlines the existing parking adequacy as well as the impact from each of the previously mentioned development/redevelopment projects.

Based on the assumptions in this study, in addition to the parking management strategies and enhancement recommended in the report, an additional 35+/- spaces are needed to meet the future parking needs. Those spaces should be located as close as possible to the new development projects.




- Primary concerns are impact of future parking availability from Springs Town Center Project.
- Concern about residents for the Springs Town Center parking on street.
- The City could adopt a policy that prohibits overnight parking.
- Primary concern is employees taking prime on street spaces.
- Truist Bank is towing vehicles from lot.
- Paid parking is not something they want in Miami Springs.
- The City has a lot of multi-generational households and the residents have become accustomed to being able to park at their destination.

Online Survey Summary

The Online **Public Survey** (via Survey Monkey) was designed to gather data on parking trends, satisfaction, and general feedback from Miami Springs residents, employees, customers, and frequent visitors. The survey was available in English and was active from August 25th to September 29th, 2023. A total of 495 surveys were completed. Below is a brief summary of the survey responses. The full survey results please find in Appendix B.

- Out of the 495 **total** responses, 443 (90%) indicated that they live in Miami Springs.
 - o <u>A majority of the respondents are Miami Springs residents.</u>
- Of the 443 **resident** responses, 111(25%) indicated that they **work** in Miami Springs.
 - <u>A majority of the **residents** who participated in the survey</u> <u>do not work in Miami Springs.</u>
- Of the 443 resident responses, 424 (98%) drive when shopping and/or dining.
 - 57% of those responses indicated their parking experience was **convenient, easy, or not too bad**.
 - 74% of those responses indicated they park in an onstreet parking space.
 - 75% of those responses indicated their visit is between 1 to 3 hours.
 - 67% of those responses indicated that it took less than 5 minutes to find a parking space.
 - For the majority of the respondents, their parking experience would be considered "good."
- Out of the 495 total responses, 52 (10%) indicated that they do NOT live in Miami Springs.
 - Of the non-resident responses, 27 (52%) indicated that they work in Miami Springs.
 - Of those, responses indicated that there is an even distribution of parking on-street and in a parking lot (owned by the employer), that a majority (53%) find parking in less than 2 minutes and most park at their workplace or within a 1-minute walk.
- Other reoccurring comments indicate:
 - There is not enough parking around the Circle or along Westward Drive.
 - There is not enough signage and information on where to park.
 - o The parking areas are not easy to access and are not well maintained.
 - o Illegal parking is commonly observed, and people park anywhere they want.
 - o Parking regulations are not followed.
 - There are not enough ADA parking spaces.







RECOMMENDATIONS

Parking Operations & Management

At this time, all parking in Miami Springs is free and the posted time limits are not being enforced. We understand the City's general fund is being used to pay for all operations, maintenance, and repairs. While the hands-off approach has worked for many years, recent development projects and growth have outpaced the traditional method of parking management. The recommendations below will allow the City to better manage the public parking resources, improve access to the downtown study area, improve compliance of the parking regulations, increase safety, and eventually generate revenue to help offset the costs associated with operating and maintaining the public parking system.

- 1. **Fund 2 FTE parking enforcement officer (PEO) positions**. This could be accomplished by allocating one or both of those positions from the police budget if overstaffed. The PEO position would allow for consistent and regular enforcement of all posted time limits, illegal parking, and parking safety concerns.
 - a. We recommend procuring a mobile license plate reader (LPR) which is mounted to a vehicle. LPR systems can assist an officer by digitally recording all parked vehicles by license plate, time, and location in order to determine if the vehicle is parked beyond the posted time limits. The automation of enforcement of time limits with a mobile LPR system allows for a high level of violation capture rates and promotes compliance with minimal staffing resources.
 - b. Posted time limits should be consistent (i.e., same on both sides of the street) and clearly stated.
 - c. Zoning codes should also be reviewed/revised to allow for the monitoring and enforcement of time-restrictions into the evening hours, especially as demand increases at that time.
- 2. Consider implementing paid parking in the on-street areas of highest demand. Paid parking coupled with time-limited parking will encourage turnover of those valuable parking spaces and shift long-term parkers (such as merchants and employees) from the high-demand on-street parking areas to off-street parking lots or less utilized on-street areas.
 - a. We recommend the use of a pay-by-plate method (mobile payment or paystation – photo right) with a rate of \$2.00 per hour (minimum) to offset transaction costs. Using those two payment methods will allow the PEO (with their mobile LPR system) to quickly verify which vehicles have paid and which are in violation.



- b. Programs for discounted or free resident parking can be included to offset the impact on taxpaying residents. We would recommend extending a 50% resident discount when parking in areas of high demand and allowing free parking in the other areas. Residents would register for the discount program by providing proof of residency and their vehicle license plate information.
- 3. Overnight parking restrictions in downtown on-street parking areas were discussed during the public workshop and if implemented, there may be an opportunity to create and sell an overnight parking permit. These permit holders could be assigned to specific locations and parking restricted to specific hours. We would recommend an initial permit rate of \$60.00 per month (minimum) which would offset administrative costs and provide revenue to fund parking system repairs and maintenance.
- 4. Consider establishing a Parking Fund that can be used, in lieu of the City's General Fund, to offset the costs associated with operating and maintaining the parking system. This fund could also be used to should any PILOP fees for development are submitted to the City.

Safety and Linkages

As the number of people parking increases, there is a need to address safety issues and provide quality linkages to/from all parking locations. The following recommendation will improve pedestrian safety, reduce vehicular/pedestrian conflicts, and improve the user experience.

1. Delineate with pavement markings or signage areas where parking should not occur due to poor visibility of oncoming vehicles and/or illegal parking (i.e., too close to an intersection).

- 2. Consider implementing enhanced pedestrian safety measures such as:
 - a. User activated or motion activated blinking lights at all crosswalks.
 - b. Utilization of raised crosswalks at critical pedestrian crossings which also serve as a traffic calming measure.
- 3. Increase lighting and aesthetically enhance pedestrian walkways connecting the parking areas to the major arteries and destinations (photo right).

4. Create a formal policy on commercial loading to minimize disruptions to traffic flow and accessibility to/from the public parking lots (photo right).









Parking Infrastructure

In order for a parking garage to completely fund itself, it must generate approximately \$250 to \$300 per space per month to cover debt service, operational expenses, and a capital reserve fund. We understand there are limited funds available at this time to subsidize the cost of constructing, operating, and maintaining a parking garage. Therefore, the following recommendations are focused on the most cost-effective methods to increase the capacity of the existing parking infrastructure.

- 1. To maximize the use of all the existing on-street parallel parking areas, we suggest striping each individual space. The delineation markings will encourage motorists to park closer to other vehicles and minimize instances where vehicles are improperly spaced.
- 2. We understand the parallel on-street parking area on Curtiss Parkway is being expanded and we recommend the same improvements on the other side of the greenway (in the north bound direction). There are currently 9 to 10 parallel spaces on the southbound side adjacent to the greenway and the southbound expansion that is underway will add another 8+/- spaces. Adding the same in the northbound direction (between Crescent Drive and the Circle) will provide for 21+/- parallel parking spaces for a total net increase of 29 parking spaces.
- 3. Extending the use of parallel parking spaces along another section from Hibiscus to Azure and from Crescent to Reinette will yield an additional 41 parking spaces within a 3-4 minute walk to the Circle.
- 4. To further maximize all of the existing area along Curtiss Parkway, the recommendations in #2 above could also be implemented with 60-degree angled parking. Converting all of the parallel parking areas to angled parking would result in approximately 76 +/- spaces for a total net increase of 66 parking spaces. We encourage the City to fully explore the Curtiss Parkway parking recommendations as they can yield a large number of new parking spaces at a low cost without significantly impacting valuable land or green space and within close proximity to the Circle.
- 5. The on-street parking capacity on Westward Drive could be nearly doubled from ~109 parallel parking spaces to ~218 angled parking spaces with the removal of one lane of traffic. This single change would increase the number of public parking spaces by almost 25%. We understand these changes may impact utilities and require additional expenses.
- 6. The lot adjacent to City Hall is the largest single publicly owned parking area in the study area and over half of those spaces are used by the City Police and County Fire employees. On-duty police officers were observed parking their marked police vehicles on Park Street adjacent to their main entrance leaving their personal vehicles parked in the lot. Likewise, County Fire employees tend to work shifts spanning multiple days and during that time, their vehicle remains parked. We understand there are certain agreements in place and history involved with the purchase of this property, however, that parking lot would be best utilized as the main downtown parking lot given its location and due to the fact that it resembles a typical parking lot (compared to the lots that are behind the commercial buildings). Additionally, police and firefighters are physically capable of walking and a slightly more distant parking area should not cause any significant hardships on mobility.

Wayfinding and Signage

The off-street parking areas in Miami Springs are not considered typical for most cities. For example, in most places, the areas behind a commercial business are typically used by employees and for other back-of-house activities such as trash collection and loading/delivery services. Miami Springs utilizes a portion of that area as a public parking lot. To better inform visitors of Miami Springs, we recommend the following:

- 1. Develop a <u>uniform signage theme or branding</u> and roll it out to all of the lots in a uniform manner. This should include an identifier within the parking lot, such as a highly visible and branded sign or flag, as well an obvious marker to note the location of the entrance to the parking lot, that it is a City lot for public use, and the name of the lot. This will allow motorists to navigate into one of the City's offstreet parking lots with less confusion than exists today. It will also allow users to retrace their steps when they need to return to their vehicle.
- We would also recommend <u>auditing the existing roadway</u> <u>signage</u> to ensure that motorists are properly informed and directed to successfully access the public parking lots. It may also be helpful to brand those signs as downtown public parking or "Circle" parking.
- 3. It would be beneficial to separate the signs needed by motorists from the signs needed by pedestrians as the two user groups have specific needs. Signs intended for pedestrian use can include more detail and information as a pedestrian can stop and read all of the information provided. Signs intended for motorists should be clear and concise to allow for quick decision making.
- 4. Many users that are not familiar with an area will attempt to park at or as close to their destination as possible so that they can see where they are going. Increasing the wayfinding signage within the parking lots will help alleviate some of the anxiety that visitors may have in locating how to find their destination. To improve the user experience, we recommend the installation of Downtown pedestrian wayfinding maps at or near all public parking lots.

Shared Parking - Master Lease Agreements

To obtain additional parking resources, the City or a designated agent could engage downtown property owners with the intent of master leasing the excess parking resources to offer to downtown employees. In this capacity, the City or its agent would facilitate parking lease agreements with owners with excess parking and thereby potentially secure a meaningful parking resource for the City that would otherwise sit empty at certain times or days of the week. The parking "aggregator" would contact property owners, negotiate the terms of the lease for their excess parking, and coordinate the provision of suitable insurance, enforcement, and property maintenance services for the leased properties. The lease agreements with owners would need to provide owners with the right to terminate with a short notice provision, say 30 to 60 days, without cause, so the property owners are assured they could reclaim their parking expeditiously should they need it for the primary function of their property.

With leasehold control of these parking resources, the City or its agent would administer the sale and provision of permits to downtown employees for the utilization of these parking resources. The cost of leasing the property and associated administrative costs would be offset by the City's sale of permits to users. The location of properties identified are listed below.

- We recommend exploring options for utilizing the parcel located at 100 Canal Street owned by Southern Bell. An agreement for the use of some or all the parking spaces would be mutually beneficial as we did not observe more than a few vehicles parked in those lots during our survey days. Another option that could be explored would be for an agreement for use by the City Police and County Fire employee vehicles as those could be easily controlled and assigned.
- 2. Truist Bank, Milam Grocery, and the office building located at 11 N. Royal Poinciana are three other privately owned parking lot sites in closest proximity to the Circle with potential sharing opportunities.
- 3. Agreements for use of church parking areas are also common in other cities and can be a great resource for employee parking. The Miami Springs Baptist Church lot and the Grace Lutheran Church lot both have sizeable parking areas that are underutilized.

Marketing and Public / Stakeholder Communication

Providing a better parking experience typically comes down to the customer experience and superior customer service. There are steps that a municipality can take to ensure a greater customer experience for its parkers:

- 1. Keep it simple.
- 2. Communicate effectively.
- 3. Ask for feedback.
- 4. Be responsive.

Keeping the customer's parking experience as simple as possible goes a long way. The less friction the process has, and the more options offered to the parker the better. Parkers do not want to have to think about parking, they would rather just do it.

Effective communication is a great tool in improving the customer experience. If the municipality provides clear communications pertaining to parking rates, policies, and payment methods, it will be easier for the parker to understand, and they will be more likely to follow the regulations set forth. Clear and concise signage is a key factor in this communication and can make the difference between positive and negative experiences for the parker. When applicable parking information should be displayed on signage, pay stations, or within the mobile

payment service, but it should also be displayed online for an easier customer experience. Municipalities can develop their own apps to provide updates on street closings, weather issues, special events, and any other information that may affect parking – improved communication leads to a greater customer experience.

Asking for feedback from parkers is important, as it is the most effective way to identify and solve problems. This feedback can be obtained through surveys that are monitored, app reviews, social media, etc. Further, responsiveness can go a long way for the customer experience. The best way to address a parkers' concern or issue is to show empathy when trying to assist with the problem and then to follow up until it is resolved. The effort makes all the difference, even if the outcome is not desirable. A better parking experience can bring in more visitors to a municipality's downtown.

5. Parking Advisory Committee

Miami Springs should consider creating a Parking Advisory Committee (PAC). This committee would meet on a regular basis, and includes representatives from the City, the PEO supervisor, the Director of the Economic Development Department, downtown residents, business owners, landlords, etc. The purpose of the committee would be to review, discuss, and identify parking issues or concerns with the intent of directly addressing problems and making recommendations to the City Council for the adoption of updated or revised parking policies and ordinances. The Parking Advisory Committee is an excellent forum for coordinating the necessary interaction and communication between stakeholders and parking management personnel. 


Q3 Do you work in Miami Springs?

Q4 Do you ever drive a vehicle to work and park in Miami Springs?







Q6 How long does it take to find a parking space when going to work?







Q11 Do you ever shop or dine in Miami Springs?



Q12 Do you ever drive to Miami Springs when shopping or dining? (this includes driving a Low Speed Vehicle)







Q17 How long does it take to find a parking space when visiting to shop or dine?





Q18 How long does it take for you to walk to your shopping or dining destination?





Q19 Do you ever visit Miami Springs for activities beyond shopping and dining (i.e. salon, spa, fitness, medical appointments, government business, etc)?







Q25 How long does it take to find a parking space when visiting for other non-shopping and dining purposes?




