RE: Florida Gas Transmission (FGT) Company – 12-Inch Miami Lateral Emergency Anomaly Repairs

Dear Mr. Gorland:

This letter shall serve as notification of emergency pipeline work that must be completed by FGT on their 12-Inch Miami Lateral Pipeline. FGT, as part of their integrity management plan, routinely tests their pipelines using hydrostatic testing or in-line inspection tools or "smart pigs". In 2007 FGT inspected the 12-Inch Miami Lateral and no anomalies were detected. However, during the 2014 inspection, critical anomalies were identified in the pipe. FGT has determined that these anomalies must be repaired and in accordance with Federal Regulations 40CFR192, FGT must initiate repairs within five days and/or reduce the operating pressure. As a precaution, FGT has already reduced the pressure on the pipeline while waiting to initiate emergency repair work.

One of the anomalies is located on SR 948 / NW 36<sup>th</sup> Street, between Lee and Forrest Drives, adjacent to the limits of the City of Miami Springs, within Florida Department of Transportation (FDOT) right-of-way. FGT intends to begin repair work at this location (internally called "Dig Site 1&2") on Friday, July 18, 2014.

The traffic control plan developed for Dig Site 1&2, submitted to the FDOT, involves closing two of the three westbound lanes of traffic on NW 36<sup>th</sup> Street. In order to minimize the duration of the lane closures, FGT intends to utilize two construction crews and work 24-hours per day at the site. The exact duration of the emergency repair work is unknown at this time, but is estimated to be two days. Access to businesses adjacent to the work zones will be maintained during construction.

FGT is also coordinating with Miami-Dade County Transit for bus stop impacts along NW 36<sup>th</sup> Street and with Miami-Dade County Aviation for impacts to traffic exiting the MIA Cargo Facility. We will provide emergency repair project status updates the City of Miami Springs as they become available.
