From the Mayor:



of our priorities was getting power restored to the Fair Haven Center/Nursing Home as well as to the seniors in our City. The City was proactive in mobilizing our debris collection contractor, Crowder Gulf, who were in the City by Monday following the storm and began debris hauling activities soon thereafter. We had the main roads of the City opened by Tuesday and over 85% of our residents had their power restored by the following Saturday. Our Public Works department, Parks and Recreation department, Golf Course and Police department staff did an awesome job and we should all be proud. A special thank you to Betty Dunn and the Lowell Dunn family for their generous gesture in allowing us to use their NW 74th St property as a staging area for debris. After Hurricane Irma

In the days before Hurricane Irma's arrival the Miami Springs Police Officers were already making preparations at home knowing well that as the storm approached they would be called upon to serve and protect. All unscheduled vacations and time off requests were put on hold. On Friday, September 8th at 1700 hours (5pm) they started their Alpha/Bravo shifts.

Miami Springs Police officers patrolled the streets throughout the days to follow looking for potential hazards and directing traffic, especially around FPL trucks with workers at downed lines trying to restore power. Police Dispatchers manned the phone lines and police radios as the calls came in from the residents asking for help while others called in for welfare checks concerned about their elderly family members.

Beware of unscrupulous business and scam artists who may try to take advantage of vulnerable storm victims and charitable Floridians in the aftermath of a disaster and in the rebuilding process.

As you recover from Hurricane Irma, you will need to share personal information to get relief benefits or replacement identification documents from government agencies and organizations: be cautious. Identity thieves may pose as government officials or representatives for government agencies. Ask for identification and when possible, initiate contact yourself using information posted on official websites or in official information dissemination areas.

Debris Clean-Up and Removal Scams, unlicensed contractors and scammers often come into the affected area prom-



ising quick repairs at discount prices. Write down the driver's license and vehicle information (make, model, and license plate number) in case you need to report the contractor to authorities. Some may demand payment up-front for work they never do, or simply lack the skills, licenses, and insurance to legally do the work. Get a written estimate that includes a description of the work to be performed, what materials are included, when the work will be finished, the price, and the address and phone number of the contractor. Read all agreements carefully and be sure that all blanks are filled in before you sign. Make sure to pay with a credit card or check, and be wary of contractors who ask for a deposit in cash or to be paid in cash. Make full payment only upon satisfactory completion of the work. Trust your gut.

If you have any doubts, take your business elsewhere.

AFTER A HURRICANE

Our City code mandates that all hurricane protection devices be removed promptly after a hurricane, to provide an egress to the property owner in the event of an emergency. Please plan to remove all protection devices within the thirty (30) days allowed by our City Ordinance below. Sec. 93-13. Maintenance of

property by owner.

(C) Accordion shutters, window awnings, hurricane panels, plywood sheets, and other forms of storm protection devices that are utilized for the protection of windows and doors in anticipa-

tion of impending hurricanes and other storm systems may be closed, lowered, placed or installed no sooner than five (5) days prior to the time that the hurricane or storm system is anticipated to reach the City. However, upon proper notification to the Police Department that the property will be vacant for a specified period of time, the aforesaid storm protection devices may be closed, lowered, placed or installed for no longer than ninety (90) days during any calendar year. Following the passage of the hurricane or storm system, and the return of the City to normal weather conditions, all Accordion shutters, window awnings, hurricane panels, plywood sheets, and other forms of storm protection devices shall be opened, raised or removed within thirty (30) days thereof. Any failure to comply with the foregoing shall be considered a violation of Section (A) above and enforced in accordance with the City's established Code enforcement procedures. It is the established policy of the City that the storm protection devices specified herein shall not be used as a method or means of providing security or crime prevention while the premises are being occupied.

If you suffered any damages to your prop-



erty, remember to apply for a permit. In general any maintenance and repairs under \$500** can be done without a permit.

However, there are exceptions as follows:

- All Structural work must have a permit.
- All Exterior Windows or Doors, new or replacement, must have a permit.
 - All Drywall work must have a permit.
 - All Stucco work must have a permit.
- All Fascia must have a permit (Per Building Official, this is a new rule as it may affect structural, roof, drip, etc.).
 - All gutters must have a permit.
- All Mechanical/Air Conditioning work must have a permit. This would include any replacement of condensing units or air handlers and any addition of duct. For other maintenance such as cleaning coils or ducts, the \$500 rule would apply.
- All Roofing work valued at over \$300** or 3 squares (3 squares=300 square feet) must have a permit and any roofing with hot mop or structural must have a permit.
 - ALL fencing must have a permit.
- Any fencing repairs where support posts or poles are replaced must have a permit. If only changing the chain link or wood panels and not changing the support posts, then the \$500 rule applies.

HUMAN RESOURCES DEPARTMENT

Did you know that in addition to handling personnel matters, the City of Miami Springs HR Department also handles risk management functions? Risk management is all about protecting the City's assets and limiting the City's liability for loss and injury. The HR Department's risk management duties include maintaining adequate insurance policies and processing all claims for City property loss, workers' compensation, and any third party claims. After experiencing both a tornado and hurricane in 2017, the department is anxiously looking forward to a safe, tranquil, and uneventful 2018!

PUBLIC WORKS DEPARTMENT

As we've all learned from Hurricane Irma, the time to prevent storm-related damage to your trees and property is well before a storm hits. Once it happens, it's too late to protect your assets. You should never trim your trees right before a storm! There may not be enough time to pick up the debris, therefore making unnecessary projectiles to your property, as well as your neighbors.

Here's a look at how you can preventative prune your trees by cutting them back to prevent and mitigate damage during and after a storm.

When you decide to preventatively prune your trees, start by encouraging proper angles: branches that extend upward at 30- to 45-degree angles. Also, look for branches that are too large to support beyond the trunk. Lateral branches should be no more than 50 to 75 percent of the trunk's diameter. Prune to create balanced crowns that promote stability and be sure to re-

move rubbing branches. Finally, don't cut back all the way to stubs.

And it's always a good idea to hire a professional if you can. They have the knowledge and experience needed to properly prune trees. If you see your trees as valuable assets, a certified arborist can help you protect those trees and prevent storm-related damage.

Don't let your trees become dangerous — protect them and yourself when you choose preventative pruning.
