

RESOLUTION NO. 2017-3751

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA, APPROVING BALLPARK MAINTENANCE, INC. TO PERFORM FIELD REPAIRS AT PEAVY DOVE; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Miami Springs (the "City") is in need of repairing the four tee ball fields at Peavy Dove by excavating the sod and soil around the clay arc to eliminate the clay lip build up and allows the transition from the infield clay to the outfield grass ("Project"); and

WHEREAS, Section 31-11(C)(2) of the City Code of Ordinances provides that the City Manager, subject to the approval of the City Council, shall have the authority to purchase supplies, materials, and services and to award contracts for purchase of supplies, materials and services when the good faith estimated total cost thereof exceeds \$10,000.00 and is less than \$25,000.00 upon the obtaining of three written price quotations; and

WHEREAS, the City's Staff has obtained three written price quotations for the Project and recommends that Ballpark Maintenance, Inc. (the "Contractor") be selected as the lowest responsible bidder to perform the Project at a cost not to exceed \$12,500.00; and

WHEREAS, the City Council seeks to authorize the City Manager to enter into an agreement with the Contractor for the Project; and

WHEREAS, the City Council finds that this Resolution is in the best interest and welfare of the citizens of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MIAMI SPRINGS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Approval. The City Council hereby approves the Contractor for the Project.

Section 3. Authorization. The City Manager is hereby authorized to enter into an Agreement in an amount not to exceed \$12,500.00 with the Contractor for the Project, consistent with the Contractor's proposal attached hereto as Exhibit "A," subject to

approval by the City Attorney as to form, content, and legal sufficiency, and to take all actions necessary to implement this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilman Best who moved its adoption. The motion was seconded by Councilman Petralanda and upon being put to a vote, the vote was as follows:


